**COURSE DESCRIPTION:** The County of San Diego Behavioral TERM providers provide services to children who are insured by Medi-Cal who can have serious/severe behavioral health difficulties. This course will help Term Providers to identify and diagnose complex conditions and develop treatment recommendations that follow the diagnoses. This training will provide tools to facilitate a rapid and reasonable identification of issues that a particular child or family may bring and methods for arriving at a diagnosis or set of diagnoses that represents the complexity of the needs of the child or family. Specific treatment concepts will also be presented.
